The purpose of this MOU is to outline the terms of the agent relationship between supporting CCA's mission in Africa.	CCA and Agent in

ROLE AND RESPONSIBILITIES

- 1. Agent shall act as an agent for CCA in their village or community.
- 2. Agent shall provide support and assistance to CCA's beneficiaries using his or her money in the designated community, subject to approval by the CCA team.
- 3. Agent shall report to CCA on activities, progress, and challenges.
- 4. CCA shall provide Agent with necessary resources, training, and support.

FINANCIAL ARRANGEMENTS

- 1. Agent shall pay a membership fee of 10,000 Naira (or equivalent in other African countries).
- 2. Agent shall have a working capital to operate independently in their area of coverage.
- 3. CCA shall compensate Agent with a 10% service charge for every assistance rendered to CCA members.
- 4. Agent shall receive a 110% reimbursement for every assistance rendered to CCA members within 48 hours.
- 5. Agent shall be responsible for expenses incurred in the course of duties.

ARTICLE 4:

DURATION AND TERMINATION

- 1. This MOU shall be effective for a lifetime, unless terminated earlier.
- 2. Either party may terminate this MOU with 30 days' written notice.

ARTICLE 5:

CONFIDENTIALITY

1. Agent shall maintain confidentiality and respect the privacy of CCA's beneficiaries and stakeholders.

ARTICLE 6:

GOVERNING LAW

1. This MOU sha<mark>ll</mark> be governed by and construed in accordance with the laws of Nigeria.
