- 2. Establish a welfare resource center for Africa.
- 3. Support community development projects and initiatives.

## **ARTICLE 3:**

### **ROLES AND RESPONSIBILITIES**

1. CCA shall provide welfare services to its members using the partner support funds.



- 2. Partner shall provide funds to support CCA's goals, reaching out to vulnerable members.
- 3. Both parties shall work together to make Africa a prosperous society though fundings. ARTICLE 4:

#### **FINANCIAL ARRANGEMENTS**

- 1. CCA shall receive Amount: \_\_\_\_\_\_ from Partner as collaboration funding.
- 2. CCA shall allocate 10% of its total revenue for life to appreciate its partner network, distributable among up to 1,000 partners, with the share of each partner determined by their respective contribution/control.
- 3. Partner shall have control over the percentage contribution (Amount contributed) of the designated funds for partner network appreciation.
- 4. Partner can add more funds to increase collaboration.
- 5. Partner can withdraw dividends as it grows as it shows in the partner dashboard from CCA website. ARTICLE 5:

#### **DURATION AND TERMINATION**

- 1. This MOU shall be effective for a lifetime, except in the event of termination.
- 2. Either party may terminate this MOU with 30 days' written notice.

#### ARTICLE 6:

#### **CONFIDENTIALITY**

1. Both parties shall maintain confidentiality and respect the privacy of each party.

#### **ARTICLE 7:**

#### **GOVERNING LAW**

1. This MOU shall be governed by and construed in accordance with the laws of Nigeria.
